

2010 Dark Tobacco Sucker Control Trial

Sponsored by Chemtura Corp. – HRREC, Springfield, TN

- NL Madole set early June
 - 4614 plants/A
 - 42" row spacing, 32.4" plant spacing
- Randomized complete block design with 4 replications
 - Plots 4 rows, 40 ft. long
- 1st topping August 7
 - Off Shoot T on all plots by dropline
- 2nd topping August 15
 - Off Shoot T by dropline to all treatments except treatment 9
- Treatment applications sprayed on August 21
 - Straight boom sprayer
 - All TG-5's, 20" nozzle spacing
 - 55 gal/A
- Data collected Sept. 15:
 - % sucker control
 - % plants with suckers
 - # axillary stalk suckers/10 plants
 - # ground suckers/10 plants
 - Fire-cured yield and quality
- Tobacco harvested early October, fire-cured


