

Regional Foliar Fungicide Trial for Dark Tobacco 2006 – HRREC, Springfield, TN

- Narrowleaf Madole set mid-June (4600 plants/A)
- Randomized complete block design with 4 replications
- Plots 4 rows, 40 ft. long, data collected from center 2 rows
 - All 4 rows treated
 - OT applications made with flat fan nozzles (15 gal/A)
 - Full coverage applications made with 18X hollow cone fine mist nozzles
 - 5 nozzles per row, 40 to 60 gal/A
- All other production practices standard
- Tobacco harvested late September, fire-cured
